Privacy Policy

We will not use or share your information with anyone except as described in this Privacy Policy.

STORAGE

If you subscribe to our ‘News’ online or submit a contact form via the website, your message and email address is stored on the website. Your message may be forwarded to the appropriate Friends Committee member(s) and, if so, will be stored on their individual computers. All Committee members must comply with the Friends Data Protection Policy.

LOG DATA

Whenever you visit our website, we collect information that your browser sends to us called “Log Data”. This Log Data may include information such as your computer’s Internet Protocol (“IP”) address, browser version, the pages of our website that you visit, the time and date of your visit, the time spent on those pages and other statistics.

COOKIES

Cookies are files with small amounts of data that are commonly used as an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your computer’s hard drive.

Our website uses these cookies to collect information and to improve your web experience. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your computer. If you choose to refuse our cookies, you may not be able to use some parts of our website.
